ACCOUNT GROUPS are local non-profit organizations without VALCORE Board representation. ACCOUNT GROUPS will encourage their supporters to bring CA redemption value drink containers to VALCORE for recycling and to donate the cash refund value to their organization. VALCORE will maintain a total of all monies donated to individual ACCOUNT GROUPS. ACCOUNT GROUPS will be paid quarterly.

ACCOUNT GROUPS earn money when their supporters bring their CA REDEMPTION VALUE (CRV) glass, plastic, and aluminum beverage containers to VALCORE during REDEMPTION HOURS (MON-SAT, 10:00-5:00 PM; 10 AM - 4:30 PM in winter). Their separated CRV containers are then weighed and the total refund value will be credited to your account. Each contributor will need to sign our log for his/her donation.

ACCOUNTS GROUPS may request VALCORE brochures to share with their members. ACCOUNT GROUPS should encourage their supporters to also donate other recyclable materials to VALCORE. Check our website [www.VALCORErecycling.org](http://www.VALCORErecycling.org) a complete list of what we accept for recycling. Our website also lists our current prices, our hours of operation and has a map to our site.

ACCOUNT groups may petition the board to become a MEMBER GROUP. Member groups share in the profits of all donated materials; they also share in the responsibilities of managing the recycling center. Member Groups are voting members of VALCORE Recycling; they appoint someone to serve on the VALCORE Board of Directors and to attend the monthly Board meetings. MEMBER GROUPS staff the center on weekdays or on rotating Saturdays, and work on various committees and special projects.

This contract must be renewed in January of each year. There is a \$10 annual fee to cover program administration costs. VALCORE Board of Directors has the right to modify or cancel this agreement with 30 day notice.
